Please note that we will be unable to post any submissions until this agreement has been completed and returned to us **with your legal name and contact information.** Please return the agreement through the submission page. We will contact you with any issues.

Please complete the entire form. We need all art submission names, type of art, size of art and category of art. If there are too many for this form, please submit and start a new form.

Owners under the age of 18 years old must have their parent or legal guardian sign this consent. Owner is what we are calling the artist because the artist owns their own work. This document is giving is permission as to how we are allowed to use it.

Simply fill in the boxes provided on the form. **If you have a pseudonym, or artist name that you use that is different from your legal name, you must provide your legal name. Type your name as "YOUR LEGAL NAME aka ARTIST NAME". You can email submissions.the.art.of.autism@gmail.com to inform us to keep your legal name confidential from the public and we will honor that.**

To complete the drop down menus:
